Problem Definition Workshops

This workshop aims to define both the problem to be resolved and the benefits that are likely to be realised to the degree they are currently known. This workshop is a powerful communications forum where the investor and stakeholders can discuss and understand the need for the investment and its implications. Whilst the primary focus of this workshop is defining the problem, it also provides an insight into the potential solution and aims to quantify the intended benefits.

The output from this workshop is the **Investment Logic Map**

Solution Definition Workshops

Whereas the first workshop focuses on the problem and benefits sought, this workshop identifies and scopes the likely solution. The solution itself is defined as the combination of changes to the way people work and interact and any physical assets required in order to support those changes taking place. The emphasis of the workshop is on determining whether the proposed solution is innovative, feasible and strategically aligned.

The output from this workshop is the **Investment Concept Brief**

Benefit Definition Workshops

This workshop will test the benefits identified in the previous workshop. The aim of this workshop is to determine the optimal set of KPI's used to monitor the achievement of those benefits and assign accountabilities for both their achievement and the provision of data during the reporting regime.
