Purpose of travel

The aim of the trip was to:

- Represent the Victorian Government and deliver a speech at the Uber Elevate Summit
 in recognition of the announcement of Melbourne as Uber's first selected international
 trial city for Uber Air (urban aerial rideshare) transport, pending federal regulatory
 approvals.
- Respond to media queries as a representative of the Victorian Government.
- Engage with stakeholders and potential investors.
- Develop an understanding of emerging global trends in technology investment and implications for the economic development portfolio.
- Gain insight into US-based veterans employment programs.

Benefits of travel to the State of Victoria

The visit reinforced the Victorian Government's commitment to forging enduring and positive links between Victoria and the US and highlighted the potential for further investment by US companies in Victoria. This was achieved by:

- representing the State of Victoria to the global media and other potential US-based investors at the Uber Elevate Summit at which Uber announced that Melbourne will be the first international trial city for its urban aerial ridesharing service – Uber Air – on 11 June.
- Minister Scott conveyed to a global audience that Victoria is an investment destination of choice for innovative companies
- meetings with potential investors occurred to convey the attractiveness of Victoria as an investment destination.

The Minister also gained insight into veteran's affairs programs in Washington D.C. The Minister met congresswoman Rose De Lauro and discussed support for veterans in the State of Connecticut. The Minister met the Director of the US Department of Commerce and discussed STEM school student exchange programs.

Next Steps / Follow Up

This trip created the opportunity to secure meetings with new potential investors and forge new relationships with representatives of Congress and the US Department of Commerce. The Minister's visit will support the building of long term investment relationships. The Victorian Government will also continue to liaise closely with the Uber Elevate team as it establishes its footprint in Victoria and progresses toward federal regulatory approvals of an Uber Air trial at the end of 2020.
