The Investment Management Standard

Developed by expert practitioners, the Investment Management Standard (IMS) comprises a suite of tools that are applied in a series of workshops and used to extract information from a select group of subject matter experts. The workshops are meant to be engaging, productive and involve structured conversation. This process culminates in outputs that allows the group to properly define their problems, outline the benefits of the investment and initiate an appropriate investment response.

An independent skilled facilitator should be on hand to guide this process. It is the facilitator's role to challenge suggestions throughout the course the IMS workshops, testing their validity and ensuring fairness and impartiality is applied.

Applying the Investment Management Standard

The IMS set the foundations for all public sector investments. For most investments it is recommended that three two-hour facilitated workshops are conducted as part of the IMS, however this may be tailored to suit the complexity and scale of the investment.

Although simple investments may be restricted to the Investment Logic Map (ILM), most investments will result in the completion of the following:

Investment Logic Map

A succinct visual narrative that forms the basis of the IMS process which outlines evidence based problems, the benefits expected from delivering the investment, along with the direction taken and outputs introduced to address those problems.

Benefit Map

The Benefit Map extends on the ILM defining the pre-requisites for the delivery of each expected benefit, how the delivery of each benefit will be measured, applying appropriate existing baseline key performance indicators (KPI) and the assignment of target KPI's.



Response Options Analysis

The Response Options Analysis (ROA) identifies strategic interventions, the assessment of their individual merit and their grouping under various response options to increase their overall effectiveness. A subjective assessment of each response option is conducted taking into consideration KPI, timeframes to reach full benefit realisation, indicative cost range, risk to benefit achievement, uncertainties, disbenefits and interdependencies. This process concludes with the selection of a preferred response option to be investigated further for investment.

Costs

As part of the engagement you might choose to complete one or all workshops for the particular investment. Shannon recognises requirements can often vary and is accommodating to tailor proposals to assist client needs.
